Welcome to the Thesis Submission System of the Faculty of Science.

Before proceeding to make your submission, please read the [Thesis Submission Guidelines](#) and ensure that the following documents are ready.

1. Thesis

The thesis submitted for examination shall be typewritten in A4 paper except for drawings, maps or tables on which no restriction is placed. The margin should not be less than 35 mm on both right and left-hand edges of each paper. The file to be uploaded in the system shall be in pdf format and preferably with bookmarks.

2. Thesis Submission Form(s)

Please download the [Thesis Submission Form](#) and seek approval from your supervisor(s). Each supervisor should complete a form individually.

3. Turnitin Originality Report

The latest Turnitin originality report which shows the similarity index shall be uploaded. You are required to contact the departmental administrative staff for the Class ID and Enrollment Password. You should consult your supervisor(s), if necessary, for refinement of the draft thesis.

4. Abstract

The abstract should be between 200 to 500 words. You should have the word count written and signed by your primary supervisor. The format shall be the same as the thesis.

5. Proof of Submission of Dataset (applicable for students registered in September 2017 and thereafter)

Students registered in September 2017 and thereafter are required to submit a Data Management Plan (DMP) to the University Libraries by the end of his/her probationary period. Students do not need to submit a DMP if (a) data is freely available on the internet or in libraries, or (b) license forbids deposit, or (c) no data was used in the research project for the creation of the thesis. Students who have submitted a DMP have to submit the dataset of their research when they submit their thesis for examination.

Please ensure that you have submitted [your dataset](#) and completed the [online RPg Data Management Plan Input Form](#). The proof of submission, printed from the Libraries' system, shall be uploaded in the Thesis Submission System.
